### General instruction:

### Product use and strict limitations of use:

This Product is for laboratory research use only (RUO) and can only be used or handled by professionals with sufficient knowledge of laboratory practices, quality and research. The Product cannot and may not be administered to humans or animals. The Product may not be used for therapeutic, in-vitro diagnostic or commercial purposes, unless with explicit written permission of Sanquin. The Product is not suitable for Investigational Use (IUO), study, training or educational purposes.
