4.1 Description of first aid measures

General notes

Do not leave affected person unattended. Remove victim out of the danger area. In case of unconsciousness place person in the recovery position. Never give anything by mouth. Take off immediately all contaminated clothing. In all cases of doubt, or when symptoms persist, seek medical advice.

Rinse mouth with water (only if the person is conscious). Let water be drunken in little sips (dilution effect). (two glasses at most). Call a doctor if you feel unwell.

The selection of the suitable gloves does not only depend on the material, but also on further marks of quality and varies from manufacturer to manufacturer. As the product is a preparation of several substances, the resistance of the glove material can not be calculated in advance and has therefore to be checked prior to the application.

PVC: polyvinyl chloride, CR: chloroprene (chlorobutadiene) rubber, Nitrile rubber
